### TERMS & CONDITIONS.

1. **Duty Timings:** For All Service Staffs on Duty time like: **8.00 am to 6.30 pm Day Shift.** On **Night Shift is 8.00 pm to 8.00am.**
2. We provide the professionally qualified nurse or attendant after our proper interview, **back ground check-up** with their health condition. We keep all their records in our office.
3. **Uniform** – If you are interested; the staff will be wearing the uniform. Because of the most of the patients are not like the medical dresses inside the house.
4. In case of **any complaints during the duty Hrs;** it should be inform to us. For Avoiding Unnecessary Problems; Do not deal with the Staff directly at any moment.
5. **Don't convey** the details of our terms & conditions; particularly payment details to the service staffs.
6. If any one of our staff may be **asked the payment details;** don't deal directly. Because of it will create unnecessary problems. Kindly advise to them to ask our office.
7. Without our knowledge; you are advised; Please **Don't Take our staff directly.** If you are interested to need that particular staff; you will pay to us one month salary is our service charge; you can take that staff up to 10 months on your direct basis.
8. If the same person is working with you, **Over the 10 months period;** you should pay an at least 5 to 7% as you wish the increment of the salary to him/her and **also 1 month salary service charge will pay to us.**
9. A staff is continuously **working 30days;** 2 days leave per month with salary. If you need the staff for those days; we provide substitute staff and you should pay for an extra charges.
10. **Bus Pass Eligibility** – If the staff is working continuously 30 days; you should pay the bus pass fare (her/him) on their hand.

11. **Food for the staff** - Lunch and 2 times Tea are Provided by you. If not possible for foods; you should pay an actual expenditure to him.
12. It's up to you; **Keep all your valuable belongings in safe custody. The staff or the management should not be held responsible for any loss.**
13. **Our staff will take full care.** But in case of any kind of **mishap** while our staff is away for short time ( Eg:- Cleaning the Bedpan, Bring some things for the patient, Lunch break etc) the staff or the management should not be held responsible.
14. **Service charges** on every proper bill payment **is applicable** for as per Government norms like GST, TDS or others extra.
15. ON occasion only; On the way of duty Hrs; if there is a **delay for** Bus Traffic, On strike, Road closed diversion etc are you should **forgive the staff** and quietly inform to the office.
16. If the **staff falls sick occasionally**; we will depute somebody else as soon as possible.
17. You should avoid asking her / him to do any type of **personal domestic works** on duty hrs (Except House maid).
18. **Patients should Co-operate** with the staff during the working hrs.
19. The Client should remit **15 days salary for an advance before starting the services. Payment must made on the second of every month without fail.** If you are going to **stop our service**; Please kindly inform **15 days before of us.** And also **deduct** the same amount from the advance payment. Kindly inform **15 days before of your Cancellation** of the duty.
20. If any dispute arises all the subjects in to the Chennai Jurisdiction only and Chennai High Court.
